1. WHERE IS THE MASON LOCATED?

The Mason is located just 35 minutes, with only one stop light, from the Salt Lake International Airport and is 10 minutes from downtown Park City. Located near Deer Valley Resort and Mayflower Mountain Resort, Deer Valley is adding the area now formerly known as Mayflower into the world-class operations at Deer Valley Resort.
